Anyway, the fact is this that Jeff was convicted of smuggling eggs in 2010, and served his time in England. The international wildlife Agency TRAFFIC, major environmental NGOs here in southern Africa with whom we currently work, all know about this.
Furthermore, the major news broadcasters, CNN, BBC, Sky News etc., all covered the case extensively back in 2010 when the story broke. There is also much on this subject on the web.
Many clients of mine in the AHG know about this and have indeed discussed this with Jeff and or me. If anyone wants more information, they have been and are – free to ask. Jeff is undertaking an administrative role in visiting the outfitters across Africa and has no ownership of the company or the program.

It is disappointing the depths a disgruntled ex-employee will go to in order to try and discredit me and my company.
