



This is a Savage Fox BSE 20 Ga. 3" Magnum with 28" Vent Rib Barrel that was made back in the later 1970's in the USA. All solid forged steel and hardwood stock. Choked Mod and Full. The shotgun is Mint and looks unfired since factory test fire. No marks or scratches or wear. Still has a factory info tag on it. Everything is working just fine. The gun feels like a new gun, tight and not yet broken in. It has Single trigger and ejectors. Blue and stock finish are original. There are two tiny machining bloms at the bore at the inside muzzle on each side. My gunsmith said it came from the factory that way. Guaranteed not to affect the shot pattern. Offered at No Reserve Auction. Guaranteed to make you very happy.

**It is best to use Priority Mail to send a letter by USPS with payment. Well worth the extra \$6! Waiting up to 2 weeks for snail mail with no tracking is very difficult.** I use the Gunbroker email address to contact you. **So Check your SPAM and JUNK email boxes, Most all gun emails go to your junk box!**

**Non-paying bidders are now being banned by Gunbroker forever. Even after just one time not paying. Please be sure you are willing and able to complete the transaction Before Bidding!**

**If you have NR status (No Rating Yet) You must email me and tell me about yourself before bidding. Otherwise I will block you. Too many non-paying NR bidders lately.**

**I Do Not use the GUNBROKER CHECKOUT SYSTEM! Don't ask me to fill out the boxes there!**

I Do NOT offer Bid Retraction so don't even ask! If there is no "Buy It Now" shown then it is not offered and cannot be added. So please don't ask. **I do not use the Gunbroker Checkout system. I do everything directly with the customer.**

**ABOUT THE AUCTION: Winning bidder must contact me by email or phone within 5 days!** If you win the auction **Go to the email they send you showing you won the auction, click on the "VIEW ITEM LISTING" box then click on the ITEM SUMMARY Box.** My address and All the information you need is shown there. **I Do Not use the GUNBROKER CHECKOUT SYSTEM! Do not click on the GUNBROKER CHECKOUT SYSTEM box, it will not help you!** If you have trouble, call or email me and I will help out. Check your spam and junk files for emails! If you put a signature requirement on your letter it will often slow down its delivery to me by up to 3 days while we play signature tag. I have not lost a letter in 14,000. Your choice and either way is fine.

I know the shipping costs are high but the shipping costs I pay to USPS is often more than I charge you. **It Includes insurance that the gun will arrive safe and sound at you dealer's shop or your money back. Shipping to Alaska or Hawaii will often cost more.**

Guns are packed with lots of thick carboard wadding rolled and packed tight around the gun. I have not had a gun damaged in shipping over many years and 1000's of guns sent.

I use the Gunbroker email address to contact you. **Check your SPAM and JUNK email boxes!**

I cannot end an Auction early so don't even ask!

I cannot add a "Buy it Now" now so don't even ask!

**GunBroker now requires State Tax to be collected from most all states, and it will be added to the total amount of the sale and shipping. It Includes insurance that the gun will arrive safe and sound at you dealer's shop or your money back.**

I have sold over 13,000 guns to happy customers by mail order on Gunbroker and other internet gun auction sites and the old Gun List paper since 1985, so bid with confidence. The name "Oregon Lumberjack" is because in my younger days I was a Logger and also did Sawmill, Plywood and Paper mill work in Oregon. I now reside in Connecticut for the last 45 years and while here I worked and studied in precision machining and metal fabrication industries before being a FFL gun dealer.

I reserve the right to relist the item in the event that the GunBroker website goes down or slows down significantly during the final 8 hours of the auction. If you are a first time GunBroker bidder with a NR (No Rating yet), you must contact me by sending an email Before Bidding! Note to rated bidders, I check 1<sup>st</sup> time or NR bidders to be sure they are true buyers and not just some kid having fun on the computer.

**ABOUT CONDITION:** The pictures are the most important part of the description of the gun! Please review them carefully and completely! If you see a flaw or have a question and want to know more, please email me through Gunbroker. No description in words can fully describe this or any gun! If you are a perfectionist do not bid on my auctions! No gun, not even NIB is perfect!

**NOS and Unfired:** Explanation of the meaning of NOS and Unfired in an Ad. When I say a gun is NOS (New Old Stock) Condition or being Unfired, That is my opinion based on the condition of the bolt face, breach area, action and bore. Your opinion may vary.

**About Returns:** Note that if you want to return the gun because you bid more on Sunday evening than you wanted to pay on Monday morning a return will not be accepted! **Returns are for serious omissions in the ad words or pictures!** Things like the wrong caliber or crack in the receiver, Not things like I don't think it is excellent now that I see it! And No Returns because now you think you bid too much or because you changed your mind or had financial problems.

Inspection is a no-firing, no disassembly, 3-day (M-F) time frame to cover any Serious issue that was NOT noted in the written description -or- Not shown in the photos of the item auction. No returns because you changed your mind! No returns based on your evaluation of condition! You evaluate condition from the pictures Before you bid! Inspection period begins at time of delivery to your dealer...it is your responsibility to inspect the gun in this time frame. Please ask questions BEFORE you bid. By bidding you agree to these rules! If you don't like these requirements then Do Not Bid!

Shipping Damage: I will not accept any returns or pay for repair costs for goods damaged in shipping without the actual original shipping box and packing materials. Must be the physical box and packing material. A Picture does Not work! Save the box and packing materials or No Refund!

**LEGAL REQUIREMENTS:**

**Sorry, No Priority Mail shipping of handguns to C&R FFL Licensees because the Postal Service No Longer Allows it (email me for a detail explanation). AlsoNo UPS or FedEx direct shipping of handguns to a C&R FFL in Any State (Due to ME & FedEx sender/shipper requirements). By the way I had my own C&R for 25 years so I am on your side! But I still must follow the New rules!**

**I can accept your C&R FFL on C&R Long guns in MOST but not all States. NO C&R Long Guns can be sent to C&R Licensees in CA, CT, NY, NJ, MA, and HI. C&R Pistols and Long guns can be shipped to a Regular FFL 01 Dealer in any state!**

For all buyers Without a FFL or C&R: ALL handguns and long guns must be transferred through a licensed FFL dealer in your area. Bidder must supply a signed copy of local dealer's license before shipment will be made. An Emailed or texted copy of the FFL from your dealer is fine, or put a copy in with your check. I no longer have a FAX.

**CALIFORNIA:** California sales are fine if the gun is on the approved roster. But you must still contact me before bidding on any handgun regardless! I will deduct a 10% restocking fee and auction costs from your refund, so be sure you can have it in California BEFORE you bid !

**PAYMENT:** Winning bidder must contact me by email or phone within 5 days! Payment must be received within 10 days of the auction or the item will be shipped. We play signature tag. I have not lost a letter in 14,000. Many smart buyers take a cell phone picture of the check and of the letter. Then you will have proof if needed if your letter is late. Postal Money Orders and Cashier's Checks ship fastest. Personal and business checks are gladly accepted and will usually only delay shipping 5 or more days for clearance. Some banks will not disclose the status of a personal check, if your bank is one of those it can take as long as 30 days for your personal check to clear. **SORRY, NO PAYPAL, NO LAYAWAYS & NO TRADES ACCEPTED**

**SHIPPING:** No Local Pick-ups! Buyer pays shipping cost shown in the ad for the lower 48 States...AK & HI are sometimes an additional charge. Handguns are shipped to your FFL Dealer by USPS Priority Mail Insured. Long guns are shipped USPS Priority Mail or FFL/FedEx with each firearm shipped. If you prefer another type of shipping, it can be arranged. I include a signed copy of my UPS with each ground insured. The name of the buyer is shown on the outside of the box as well as on the paperwork inside the box. Please note that purchases cannot be "picked up" at my location...all firearms are shipped. U.S. sales only, no exports...this includes antiques.

**SAFETY NOTICE:** Buyer is solely responsible for determining that a used gun is safe to shoot! The firearms offered have not been test fired! They have been given a visual inspection for auction purposes only. I am selling this gun as a collectible item used! I make no guarantee that it is safe to shoot or that it will function correctly if it is fired. It is a requirement that every used firearm (including this one!) be inspected and approved by a qualified gunsmith before firing! By bidding, the buyer agrees to hold seller harmless against damages, injury, or death caused by defective merchandise.
