

# SCENTBLOCKER<sup>®</sup> SAFARI SWEEPSTAKES

1. **Promotion Period:** The ScentBlocker<sup>®</sup> Safari Sweepstakes (the “Safari Sweepstakes”) begins at 3:00:01 p.m. Eastern Time (“ET”) on Monday, August 1, 2011 and ends at 2:59:59 p.m. ET on Wednesday, February 15, 2012 (“Promotion Period”). The computer of Big Prize Giveaways, LLC (the “Administrator”) is the official timekeeping device for the Sweepstakes. ScentBlocker<sup>®</sup> is a registered trademark of Robinson Outdoors Products, LLC (“Robinson” or the “Sponsor”), a Delaware limited liability company.

2. **How To Enter:** THERE IS NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THIS SWEEPSTAKES IS VOID WHERE PROHIBITED BY LAW. If you are not already a “fan” of the official ScentBlocker<sup>®</sup> Page, you will be required to become a “fan” of that Page (also known as choosing to “like” the Page) during the Application process; you do not have to remain a “fan” after the Application process is completed. Except for Wednesday, August 1, 2011, a day starts at 12:00:01 a.m. ET. The day of Wednesday, August 1, 2011, starts at 3:00:01 p.m. Except for Wednesday, February 15, 2012, a day ends at 11:59:59 p.m. The day of Wednesday, February 15, 2012, ends at 2:59:59 p.m. ET. Entries must be submitted by 2:59:59 p.m. ET on Wednesday, February 15, 2012, to be eligible. Use of any automated system to participate is prohibited and may result in disqualification. There is no charge for entering as free Internet access is available at many public libraries.

3. **Prizes:** There will be one (1) Grand Prize; five (5) Second Place Prizes; five (5) Third Place Prizes; five (5) Fourth Place Prizes; and five (5) Fifth Place Prizes. All prizes in the aggregate have a total approximate value of \$27,849.75.

- a. - e. Each of the five (5) Fifth Place Prizes will consist of the following: Scent Shield Bone Collector 6-Pack (value \$49.99 each; total value: \$249.95).

4. **Eligibility:** The Safari Sweepstakes is open to legal residents of the United States who are at least 18 years of age or of the age of majority in their state of residence, whichever is older, as of their date of entry. THERE IS NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THIS SWEEPSTAKES IS VOID WHERE PROHIBITED BY LAW. Employees of the Sponsor or the Administrator and any of their affiliate, parent or subsidiary companies, and advertising and promotion agencies, and members of their immediate families (spouses, parents, children, and siblings and their spouses) and/or those living in the same household of each are not eligible. 5. **Random Selection:** The Prize Winners will be selected in a series of random automated drawings, commencing at 3:00:01 p.m. on Thursday, February 16, 2012 from among all properly submitted eligible entries received. The person who submitted the entry selected in the first five (5) drawings will be the Potential Fifth Place Prize Winners; the persons who submitted the entries selected in the next five (5) drawings will be the Potential Fourth Place Prize Winners; the entries selected in the next five (5) drawings will be the Potential Third Place Prize Winners; the entries selected in the next five (5) drawings will be the Potential Second Place Prize Winners; and the entries selected in the next drawing will be the Potential Grand Prize Winner. Once an entry is selected for any level of prize, that entry shall not thereafter be eligible for further selection for any other prize (although the person who submitted that entry may remain eligible for additional prizes if he/she has submitted multiple entries to the Safari Sweepstakes). The random automated drawing will be conducted by the Administrator, which is an independent sweepstakes/promotion administrator organization, at its office in Columbia, South Carolina USA. The decisions of the Administrator and the Sponsor are final and binding on all matters relating to the Safari Sweepstakes.

6. **Verification and Notification of Prize Winners:** Each Potential Winner is subject to verification by the Administrator, and must continue to comply with all terms and conditions of these Official Rules. Each Potential Winner must respond in the manner stated on that website address and in that e-mail, within seventy-two (72) hours of the random automated drawing. - a. *Second, Third, Fourth and Fifth Place Potential Winners.* After response from the Potential Second, Third, Fourth or Fifth Place Prize Potential Winners and verification of eligibility, the Administrator will cause the Second, Third, Fourth and Fifth Place Prizes to be sent to the validated Winners. If, however, a selected Potential Winner is determined to be ineligible by the Administrator and/or the Sponsor, or fails to respond within the required time period, that Potential Winner forfeits his/her Prize and is disqualified. In the event that a Potential Winner is disqualified for any reason, the Administrator will randomly select a different Potential Winner of the forfeited Prize from all remaining eligible entries and repeat the notification and verification process outlined above. The Administrator will continue repeating that process until validated Prize Winners are determined for all of the Second, Third, Fourth and Fifth Place Prizes have been awarded. State of South Carolina, without giving effect to any choice of law or conflict of law rules (whether of the State of South Carolina or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of South Carolina; (iv) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes, or the awarding of any Prize, shall be resolved exclusively by the United States District Court or the appropriate South Carolina State Court located in Columbia, South Carolina; (v) to the fullest extent permitted by law, by participating in the Safari Sweepstakes, you agree to the personal jurisdiction of such courts and waive any right of change of venue, *forum non conveniens* or like right; (vi) you will bring any action regarding the Safari Sweepstakes individually (not as part of a class action); (vii) your recovery shall be limited to actual out-of-pocket costs incurred in participating in the Safari Sweepstakes (if any) and waive any and all other damages (including but not limited to compensatory, punitive, consequential or incidental damages and any and all rights to have damages multiplied or otherwise increased) as well as any right to attorneys' fees. - e. *Termination or Disqualification:* The Administrator and/or the Sponsor reserves the right to cancel, suspend and/or modify the Safari Sweepstakes if any fraud, technical failures or any other factor beyond the Administrator's and/or Sponsor's control impairs the integrity or proper functioning of the Sweepstakes, as determined by the Administrator and/or Sponsor in their sole discretion. In such case the Administrator shall select the Potential Winners from all eligible entries received prior to the action taken. And, notice of such action by the Sponsor and the Administrator will be posted on <http://www.bigprize.com/fans/contests> and/or on the ScentBlocker® Page. The Administrator and/or Sponsor reserves the right in their sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Safari Sweepstakes or to be acting in violation of these Official Rules or any other promotion administered by the Administrator or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, the Administrator and the Sponsor reserve the right to seek damages from any such person to the fullest extent permitted by law.
